UACEP as a 501 c3 Non-Profit

RATIONALE

- Finance handling
- Protection against event/speaker liability
- Increased ability to engage in political advocacy

CONCERNS

- Misappropriation of tax payer money
- Inability of public ed. to participate
(Note: this could have been a result of our membership structure requiring individual instead of organizational membership. We could change that and charge a registration fee for all meetings and events to cover costs.)
- UACEP would be the first state employee run organization to form a 501c3 which could be problematic
- State employees engaging in any sort of political advocacy as employees is extremely dangerous.

FINDINGS

- If funds are used for event costs only, we should be on safe ground.
- If UACEP does not engage in any form of political advocacy we should be on safe ground.
- Public ed. representatives in the focus group did not know of any rules prohibiting involvement in relevant non-profit organizations.
- The Utah School Counselor Association is a confirmed 501c3 and is made up strictly of state employees.

RECOMMENDATION #1


Higher ed. CE directors and public ed. CE district administrators present a proposal for UACEP to incorporate and UACEP bylaws to their legal councils and government representatives to see if they have any concerns about our forming as a non-profit, and if they have concerns regarding employees of their institution or district joining. If there are no concerns given the organization purpose we should be safe to move forward.

RECOMMENDATION #2

When it comes to political advocacy, if UACEP members identify issues that collectively we agree are problematic, we can individually contact our government relations representatives at our individual institutions and they will consult with one another to decide if it is worth adding as an agenda item during the legislative session.
